## **Handling and Storage**

#### **Precautions:**

Do not breathe dust. Wear suitable protective clothing. In case of insufficient ventilation, wear suitable respiratory equipment. If you feel unwell, seek medical attention and show the label when possible. Avoid contact with skin and eyes. Keep away from incompatibles such as oxidizing agents.

Keep container tightly closed. Keep container in a cool, well-ventilated area. Do not store above 25°C (77°F).
